Computer Use Agreement

In requesting the activation of a student account I, \_\_\_\_\_, a Uniontown school district student, understand and agree with the following information pertaining to the school district computers, computer software, and other technological facilities.

1. I am solely responsible for the computer and computer software assigned to me and for any software files residing in my personal directory of the computer network. These files are the property of Uniontown Area School District. I am responsible for any and all damage done to the computer I am using that falls outside of the normal wear and tear as determined by the District.

2. I will not reveal my network password to other user nor will I access or attempt to access another user's account, or try to learn his/her password. Violation will result in permanent loss of computer privileges.

3. I will not vandalize or otherwise abuse school district technology. I am responsible for the cost of repair(s) for any and all damage done to the computer I am using by me that falls outside of the normal wear and tear as determined by the District. I am responsible for damage to technology equipment entrusted to my care. I will immediately report any computer vandalism, computer malfunction, or other situation which has made my assigned computer inoperable.

4. I will not attempt to illegally enter computers, the computer networks or try to circumvent security in any way (remote proxies etc.). Violation will result in permanent loss of Internet privileges and / or loss of computer privileges.

5. I will not copy, download and / or install any software onto the computer networks or onto any hard drive of a computer, either stand alone or connected to a network. I will not use any personal software or games from floppy disk drives, USB Devices, the hard drive, CD ROM drives or network drives of any computer. I will not play games from the Internet during school hours.

6. I will not alter, delete or copy any DOS, Windows, Linux or network files. I will access only those files which support my purpose for working on the network that I have been given access to via my login account.

7. I will not use profane, harassing, ethnically intimidating or disparaging language in any form on the network or on any stand alone computers. I will not attempt to access CHAT, Messenger services and / or outside email from school. I will not access or attempt to access any site deemed inappropriate by the District. Violations will result in loss of Internet privileges and / or loss of computer privileges.

8. I will not create or introduce into any computer system either owned, leased, or maintained by the school district, a computer program (eg. a virus, trojan, worm, malware, etc) that invades, disrupts, absorbs, or destroys a legitimate computer program and/or data. Nor will I alter the settings, wallpaper or screen savers or any of the settings of any machine I use. Violations will result in loss of computer privileges.

9. I understand this computer use agreement and will abide by its provisions. I further understand that any violation of this agreement will be governed by citizenship, discipline codes and UASD Technology Policy and will result in loss of computer privileges.

10. I understand the Crimes Code of PA SECTION 3933, Unlawful Use of a computer, and that such offenses are punishable by law as either a misdemeanor or a felony.
